UPDATE FROM YOUR BOARD PRESIDENT

As you are aware the project to re-pipe all units to replace the polybutylene pipes is an approximately three-year project started in 2018. The permits for the 3/2 units were pulled by the plumbing contractor in anticipation of continuing this project, but due to COVID-19 the Association stopped all major projects not essential to our community. As the re-pipe requires homeowners to allow workers in their units, we felt it was prudent to suspend the project at that time. Fortunately, the City has agreed to extend our permit. We understand the health and safety of our homeowners/residents are the primary considerations in this matter; however, we also understand that replacing the polybutylene pipes is an improvement of great importance to our homeowners. The board will discuss continuing this project at our next board meeting in August.
